### NOV 23, 2022

### Dornalla Multispeciality Centre

We built a multispeciality educational centre for Children with Intellectual Disabilities, which accommodates over 80 children residing in Dornalla and the surrounding areas, as the nearest specialised centre is more than six hours away.

### JUN 10, 2022

### Honorary Doctorate

Our Co-Founder, Anne Ferrer, received an honorary doctorate from The University of Girona in Spain. The University Board recognised Anne Ferrer's commitment to working with rural communities in India and leading by example through her work and life.





We assisted the local government teams in providing immediate relief to families in distress due to the Anantapur Floods that happened in October 2022.

### JUL 4, 2022

### National Sevaa **Dharmik Award**

Our Executive Director, Anne Ferrer, received the National Sevaa Dharmik Award conferred by the Latha Raja Foundation. She was awarded for her selfless contribution to society for decades.

### OCT 12, 2022

### **Anantapur Floods**

Cooked meals and drinking water were provided to 8,700 people from 10 colonies in urban areas of Anantapur, and two medical teams visited the affected areas to conduct camps.



### FEB 15, 2023

### Livelihoods through Auto **Rickshaws under the Sthree** Shakti Project

In our efforts to create income generation programmes for women as part of our 'Sthree Shakthi Project', we distributed Auto Rickshaws to 23 women from different parts of Andhra Pradesh and Telangana.





### JUN 30, 2023

### Dharmavaram **Sports Centre**

RDT's Sport for Development Sector, Anantapur Sports Academy, built a Sports Centre equipped with digital education in the Dharmavaram Sports and Education Centre. RDT has built a new block that will have computers and library facilities to equip around 120 children with access to play.

### FEB 25, 2023

### Inauguration of Academic **Block and Hostel in** Polytechnic College

We built and inaugurated the new Academic Block and Hostel in Government Polytechnic College, Anantapur.

The hostel facility for 250 girls and the Academic Block with 10 classrooms will further encourage rural students to pursue STEM education.







### APR 3, 2023

### Visually Challenged **Students Wrote Board Exams Digitally**

For the first time in Andhra Pradesh, six visually challenged students from the RDT Inclusive High School wrote their 10th Final Examinations digitally, without the help of a scribe, using the NVDA software (Non-Visual Desktop Access) at the Rapthadu Government High School.

### JUN 27, 2023

### Athletes at the **Special Olympics**

4 differently abled athletes from our Bathalapalli ID Centre represented India at the Special Olympics World Games in Berlin in Badminton, Table Tennis and Powerlifting. They secured a gold medal in Badminton and Table Tennis and two bronze medals in Powerlifting and Badminton. India secured 202 medals in total, of which our special athletes secured 6.



### AUG 4, 2023

### **Telangana Floods**

RDT actively supported government teams and civil society in assisting people affected by the floods in Telangana's Bhupalapally, Mulugu and Warangal districts. Relief packages were provided to 8,000 people and emergency response teams worked to ensure food, water, clothing, bedding, personal hygiene products and medical assistance for the affected people.

### AUG 29, 2023

### **Rural Girls Athletics Held**

Rural Girls Athletics 2023 saw the participation of 350 spirited girls from 38 different regions in Andhra Pradesh and Telangana gathered at the Anantapur Sports Academy for three days. The young athletes competed across six categories, including 100M, 200M, 400M races, 4 X 100 M relay, Long Jump and Shot Put.





### Mana Bhoomi completes one year

The initiative celebrates its 1st Anniversary in 2023. 1,312 people were trained through sessions on environmental awareness and about the importance of making sustainable choices.

### OCT 8, 2023

We started our ManaBhoom initiative in June 2022, aiming to build environmental awareness and to promote sustainable projects that benefit our mother earth under the slogan "Mana Bhoomi, Mana Illu."

### **SEPT 25, 2023**

### Anusha represents India at the Asian Games

Anusha Bareddy, the young allrounder cricketer from our Sports for Development Programme, participated in the 19th Asian Games in China as a part of the Indian Women's Cricket Team and won the title in the team's debut at the Asian Games.

### EQUALITY

### CREATING ACCESS TO EDUCATION FOR WOMEN AND FACILITATING THEIR PARTICIPATION IN SPORTS.

RDT assists in professional and technical education and has supported 3,351 girls, enabling them to pursue graduation and post-graduation in some of the best institutions in the country. The Professional School of Foreign Languages achieved an 87% employment rate for students.

Additionally, through supplementary education, RDT operates 1,377 tuition centres, providing vital support for children at the primary level and further enriching their educational foundation. With the aim of fostering development through sports, 3,087 girls are participating in grassroots programmes in various sports, such as Cricket. Football, Hockey, Judo, Softball, Kabaddi, Kho-Kho, and Archery.

### INDEPENDENCE

RDT AIMS TO NARROW THE GENDER GAP AND PROMOTE WOMEN'S INDEPENDENCE BY CREATING TRAINING **OPPORTUNITIES FOR ECONOMIC RESOURCES AND INCOME** GENERATION.

To reduce the gender gap and foster economic independence, 28,503 women have utilised the Women Development Fund for income generation opportunities, supporting women in their smallscale businesses such as livestock, saree business, bookbinding, and tailoring. Additionally, 7,919 sanghams operate mini-banks with 88,308 women members, boosting financial inclusion. 23 women were trained to drive auto rickshaws and received them as part of the Sthree Shakthi Project.

### SAFETY

### SECURING THE WELL-BEING OF WOMEN THROUGH DIGNIFIED HOUSING AND ACCESSIBLE HEALTHCARE.

In fostering a secure environment that encourages women to actively participate in public and community life in 2022-2023, RDT has constructed 1,719 houses in the name of women, ensuring their access to dignified shelter. Additionally, to promote their overall well-being, 15,204 women were supported in institutional deliveries through the RDT Rural Hospital Network, and 7,068 G&O surgeries were successfully performed. Various orientations, workshops, counselling sessions, and training programmes were organised for women. These awareness initiatives, led by health organisers, covered a spectrum of health aspects, contributing to the comprehensive well-being of the women in the community.

### CASE STUDY

## ACCELERATING TOWARDS EQUALITY

In a society where traditional gender roles have long defined who does what, for many, driving has always been a man's task. That is where Nagalakshmi is breaking gender barriers and conquering new spaces.

Becoming the first auto-rickshaw driver in her community, defying stereotypes. Her journey is inspirational. Married at a young age, she had two children to take care of when her husband died. Yet, her determination to overcome obstacles drove her forward.

"I really like that my mother drives a rickshaw. Other women see my mother as an inspiration when they see her drive," says 14-year-old Dhanalakshmi. 23 women, including Nagalaskhmi, have been taught to drive and have received auto rickshaws as part of RDT's efforts to promote income generation and economic independence among women, especially single mothers.

Under the Sthree Shakthi Project, more women like Nagalakshmi have access to regular health checkups and group counselling sessions. The Programme not only teaches women how to drive but also imparts invaluable skills, including selfdefence, digital literacy, basic mechanics, first aid, and emotional management. "PEOPLE IN THE VILLAGE DID NOT BELIEVE ME WHEN I TOLD THEM I WAS ATTENDING AUTO DRIVING CLASSES HELD BY RDT. MY MOTHER DIDN'T WANT ME TO ATTEND THE CLASSES EITHER, BUT I CONVINCED HER. ### ACCESSIBILITY

IMPROVING ACCESS TO QUALITY & ESSENTIAL HEALTHCARE IN RURAL AND REMOTE COMMUNITIES

RDT believes that access to quality healthcare should be universal. We work towards creating access to quality healthcare in rural communities through three general hospitals, a rural clinic and two mobile clinics. In 2022-23, 8,00,000+ people availed of treatment at the RDT Hospital Network, and 26,205 people availed of treatment through our mobile clinics.

Additionally, to enhance the lives of individuals with disabilities, 957 orthopaedic surgeries were conducted, and 4241 aids and assistive devices were delivered to persons with disabilities. 983 children were actively involved in the early intervention programme.

### ASSISTANCE

### MAKING QUALITY MEDICATIONS, SERVICES AND CHECKUPS AFFORDABLE FOR ALL.

The Department for Infectious Diseases at RDT Bathalapalli Hospital currently serves 7,943 patients who are registered under ART Therapy, with an impressive 97% adherence rate and 0% vertical transmission rate from mother to baby.

Through RDT's healthcare network, 865 patients were referred to higher institutions. 3,044 single mothers were provided with access to checkups and medical assistance, 6,748 adults and 4,208 children in 199 villages were provided with nutrition.

Additionally, 10 reverse osmosis plants were installed to ensure clean water, and 1,857 combined bathroom-toilet facilities were constructed in 2022-23 to promote hygiene and well-being. © Katia Álvarez Charro

### A W A R E N E S S

### WORKING TOWARDS COMMUNITY HYGIENE, HEALTH, AND WELL-BEING THROUGH AWARENESS.

Awareness is crucial in preventing and mitigating the impact of diseases. RDT regularly conducts awareness workshops, camps, and capacity-building sessions at different levels. This includes workshops on reproductive health and anaemia prevention for adolescents. 345 general awareness camps promoting health and hygiene in villages, workshops for women in 90 villages to combat anaemia, along with 51 awareness workshops on sanitation were conducted this year.

Additionally, 2 HIV counsellors and a team of 16 health organisers covering 234 villages are working towards raising awareness and providing support for patients with infectious diseases and other ailments.

Our 9 rehabilitation centres for children with disabilities focus on awareness, capacity-building, and promoting their overall well-being.

### CASE STUDY

## **RESILIENT RECOVERIES** THROUGH TIMELY DIAGNOSIS

"Our daughter Prema was three months old when she started vomiting milk and was not able to hold anything in her stomach. We took her to a private hospital in Anantapur; they told us she had a blood problem and gave her transfusions, but they could not detect the problem, and each transfusion cost a lot; I'm a daily wage worker, and my wife is a housewife, we could hardly afford it."

"Her blood was sent for a thorough check-up, and she was diagnosed with Thalassemia; we were referred to RDT Bathalapalli Hospital, where they treated my daughter with the utmost care, and 90% of the transfusion costs were covered by RDT," says Prema's father.

Prema, who is now six years old, is steadily recovering after receiving a bone marrow transplant from her brother.

RDT Bathalapalli Hospital works towards reducing Thalassemia cases through screening and HBLC tests. Awareness sessions for pregnant women and parents of children with Thalassemia are regularly conducted to help manage the blood disorder.

"Since last year, we have screened 5,300 mothers and avoided five thalassemia-positive births," says Dr Dasaratha Ramaiah, HOD, Department of Paediatrics & Neonatology at RDT Bathalapalli Hospital.

### COMMUNITY

### CREATING AWARENESS AND ENCOURAGING PEOPLE TO PARTICIPATE IN THE COMMUNITY'S WELL-BEING.

RDT believes change starts with oneself. That is why we use a holistic approach towards sustainability in all of our initiatives. 2,897 people have joined 321 Ecology Development Committees, and 2,619 villages are involved in sustainable livelihood practices through awareness building and sensitisation among the rural communities over the years till 2022- 23.

As part of our Manabhoomi initiative, a total of 1,312 adults and 528 children were trained in Solid Waste Management, segregation of waste and alternatives to single-use plastics in 2022 - 23.

### **SUSTAINABILITY**

### PROMOTING AND ENSURING ECONOMIC AND ENVIRONMENTAL SUSTAINABILITY AT ALL LEVELS.

Protecting the land and its natural resources is a daily action. RDT, through its initiatives, works towards ensuring both economic and environmental sustainability and management of natural resources. A total of 24,360 drip irrigation systems, 614 solar panels and 670 micro sprinklers were installed over the years till 2022-23 to help farmers in droughtprone areas.

2 percolation tanks, 26 check dams and 325 farm ponds were constructed in 2022-23 to help farmers as well as to increase the water table in RDT working areas.

With agriculture in focus, to ensure medical care for farm animals, Veterinarians work in 584 villages in RDT's areas of work. Over the years till 2022-23, 5,221 animals were treated, providing 4,072 desparasitation, 2,244 vaccines and 560 fertility treatments, helping farmers obtain nutritionally beneficial food, such as milk and poultry products.

### FUTURE

### SECURING A FUTURE FOR FARMING AND FARMERS, WITH AID AND SUPPORT FOR WORKERS AND THEIR BUSINESSES

A sustainable future in harmony with nature is at the heart of our projects. To achieve this, we have been working with rural communities, especially with farmers, ensuring an eco-friendly approach towards farming and lifestyle.

In order to help people achieve a healthy life, 2,85,071 fruit trees were distributed to promote horticulture, 1,63,286 kitchen garden plants were given to families, promoting organic farming and 189 kilos of seeds were provided to 40 farmers in 7 villages in 2022-23 to encourage crop rotation.

Additionally, 3,86,158 plants were dibbled as part of our afforestation efforts, and 76 kilometres of avenue plantation were planted to improve the green cover, this year.

### CASE STUDY

## DREAMS THAT GET WIDER

Shilpmma's life changed when she started organic farming. Together with her husband, she raises two cows to sell milk for a living and grows her own vegetables to provide for her family; all with the support from RDT.

Me and my husband start very early, we are on our feet at 5 am. While one of us cleans the barn, milks the cows and waters the field, the other goes to the market to sell the milk."

Being vital members of their community, Shilpamma and her husband run the dairy from which they sell 15 litres of milk every day. An avid participant in committee meetings and support groups for farmers, Shilpamma is also the leader of her village's sangham and the diary cooperative, which benefits 90 families. Thanks to the implementation of a sprinkler irrigation system and the construction of a reservoir as part of RDT's ecology projects, Shilpamma was not only able to save water but also make more sustainable use of her resources.

"We no longer depend on the rain or fear drought as much: the contained water allows all the land in the area to benefit", says Shilpamma

Now, with bigger ambitions for a better future, Shilpamma wants to widen her fields, increase production, and be able to sell food crops. In this way, the family will increase their income and secure a dignified and sustainable future. In these efforts, RDT runs 1,377 supplementary schools throughout Andhra Pradesh and Telangana, equipping children to have access to education.

To create reliable transportation option 40,891 bicycles were distributed to girls and boys to support them in pedalling towards their dreams.

The Professional School of Foreign Languages also achieved an 87% employment rate for its students with a focus on securing dignified employment.

### CASE STUDY

## SPINNING DREAMS INTO REALITY

"I believe in hard work and it has never failed me," says Anusha Bareddy, a name that now shines brightly in RDT's Sports for Development Programme, Anantapur Sports Academy. Her journey from working in rice fields to becoming a gold medalist at the 19th Asian Games Women's Cricket in China 2023 is a tale of determination and dedication.

Anusha's passion for cricket began in the 8th grade when her school's Physical Education teacher recognised her immense potential and encouraged her to pursue the sport.

Her growth has been remarkable: after making her mark with the Under 23 team and winning the Asia Cup in June, she was immediately selected to compete with the senior team a month later in Mirpur, Bangladesh. Some 2,000 kilometres away, her parents, Lakshmi Devi and Malli Bareddy, watched her impressive debut on TV in Bandlapalli, their hometown. "When they handed Anusha the national team cap, I got goosebumps. But halfway through the match, we had to go work on the farm, which is our source of income," comments her father, a farmer by profession.

Her journey through the academy has paved the way for many other girls in this sport. "The cricket programme for girls started with me; there were no other female players. Two years later, my first teammates started to arrive, and now we have a whole team. That's the change we've achieved," she says with the biggest smile. She's currently in her final year of a bachelor's in computers and says, "I feel sports and education go hand in hand; one is my passion and the other is my platform to prove myself academically"

Emerging as the most famous left-hand spinner in Anantapur, Anusha Bareddy has become an icon for a new generation of female cricketers who aspire to achieve what she has. Her journey exemplifies the strength of self-belief, hard work, and a passion for the game that knows no gender. "THE CRICKET PROGRAMME FOR GIRLS STARTED WITH ME THERE WERE NO OTHER FEMALE PLAYERS. Individuals' economic independence is essential for the development of families and communities. In the year 2022-23 we equipped 28,503 women to embark on the path of financial freedom through incomegeneration activities.

Alongside, we worked with 5,319 persons with disabilities to establish income generation activities to improve their financial security.

Through our efforts, 11,916 persons with disabilities accessed MNREGS job cards.

## DIGNITY

In our active collaboration with communities, we have contributed to building essential infrastructure and enhancing government initiatives.

In 2022-23, we supported 4 government educational institutions and 15 Anganwadis in improving their infrastructure. 27 community centres cum supplementary schools were constructed to create a space for communities and improve access to education.

This comprehensive approach aligns with our vision to promote self-sufficiency and pave the way dignified and prosperous future for all.

## CHANGE

## FOSTERING CHANGE IN RURAL COMMUNITIES AND EQUIPPING WOMEN AND PERSONS WITH DISABILITIES WITH ACCESS TO **RESOURCES**.

RDT's objective centers on fostering change in rural communities, with a focus on equipping women and persons with disabilities.

In 2022-23, 25,071 individuals have been bought together within 1,967 Vikalangula Sanghams. Additionally, to address the concerns of the community, 1,708 people participated in Mandala Samakkhyas.

Extensive training was given to 16,459 participants in leadership and public speaking to ignite their interest in community engagement.

# A SAFE PLACE TO COME BACK TO

It was six o'clock on a rainy evening. It's been 14 years, but Venkamma remembers it like it was yesterday. "It wasn't the first time there was a storm, but it was the first time I felt afraid. I was at home with my daughters and daughters-in-law. They had all recently given birth, so four babies were sleeping when the water came with force", she remembers. It was then that the group of women saw the round bamboo boats used by fishermen crossing the rivers that had become the streets of their village.

"For the 2009 floods in Kurnool, our emergency teams distributed basic necessities like food, blankets and water, and we knew we had to do more. The housing programme had been continuing for years, but this was the first time we built houses because of a flood," says Shekhar, the RDT regional engineer who has been working in the area for 24 years. For Venkamma, 2009 was a bittersweet year. "On the one hand, I was overcome with sadness. I had lost everything I had, not only what was inside the house but also my livelihood. It took us months to be able to cultivate our land again", she says. "But it was also a year that changed my life for the better. RDT built the new houses in the women's names. Suddenly, I went from having nothing to owning a house," says Venkamma with pride.

Dignified housing serves as a cornerstone for equipping individuals with self-confidence and self-sufficiency. RDT works to reduce the impact of natural calamities through the construction of housing infrastructure for rural communities. "ON THE ONE HAND, I WAS OVERCOME WITH SADNESS. I HAD LOST EVERYTHING I HAD, NOT ONLY WHAT WAS INSIDE THE HOUSE BUT ALSO MY LIVELIHOOD. IT TOOK US MONTHS TO BE ABLE TO CULTIVATE OUR LAND AGAIN", SHE SAYS. "BUT IT WAS ALSO A YEAR THAT CHANGED MY LIFE FOR THE BETTER. RDT BUILT THE NEW HOUSES IN THE WOMEN'S NAMES. SUDDENLY, I WENT FROM HAVING NOTHING TO OWNING A HOUSE."
