INVITATION FOR EXPRESSION OF INTEREST (EOI)
FOR THE CONSTRUCTION OF CIVIL WORKS

1. Introduction

RURAL DEVELOPMENT TRUST, a public trust registered under the provisions of Registration Act, having its registered office at Door No: 28-4-408, Bengaluru Road, Ananthapuramu - 515001, invites **EXPRESSION OF INTEREST (EOI) / OFFERS** from experienced and qualified contractors, construction firms, and engineering agencies for various construction and infrastructure development works.

The purpose of this EOI is to identify competent agencies for execution of civil construction projects as per required quality standards, safety norms, and timelines.

2. Objectives

The main objectives of inviting the EOI are:

- To identify experienced construction agencies
- To ensure quality and timely completion of works
- To maintain transparency in contractor selection
- To create a panel of qualified contractors
- To engage agencies with adequate work force, machinery, and technical expertise.

4. Scope of Services

The selected agencies may be required to:

- Carry out planning and site assessment
- Execute civil and structural works
- Supply materials and manpower
- Maintain quality and safety standards
- Complete works within the approved timeline
- Submit completion reports and hand over the project

5. Eligibility Criteria

Interested firms/agencies should have:

a. Legal Registration

- o The bidder shall be a legally registered contractor, company, firm, or agency with valid registration certificates.
- o The bidder shall possess valid GST and PAN registrations.

b. Experience

- o The bidder shall have a minimum of 5 years of experience in executing similar construction projects and completed an average of at least 2 or 3 similar construction projects in the last 3 financial years.
- o The bidder must have proven experience in executing works for Organizations, Trusts, and societies or similar entities and must have successfully completed at least two such projects.
- o Only contractors, company, firm or agency enlisted with the organization shall be eligible to participate and submit an EOI.

c. Financial Capacity

- o The bidder shall have a minimum average annual turnover of Rs. 50 lakhs to 1.00 Crore during the last three consecutive financial years.
- o The bidder shall possess sound financial capability and submit audited financial statements and/or turnover certificates for the last three consecutive financial years.

7. Evaluation Process

- o The EOIs will be evaluated based on:

- o Technical experience
- o Construction capability
- o Financial strength
- o Availability of manpower and equipment
- o Quality and safety practices
- o Shortlisted agencies may be invited for tender participation or further discussions.

8. Important Conditions

- Incomplete applications or applications received after the deadline or submitted through any other mode of submission will be summarily rejected.
- RDT reserves the right to seek additional information/clarification from any applicant.
- No EOI-related costs or expenses incurred by the applicant shall be borne or reimbursed by RDT.
- Submission of EOI does not guarantee shortlisting or invitation to bid.
- All information furnished by the applicant shall be treated as confidential and shall be used only for evaluation purposes.
- Any canvassing or lobbying by the applicant or on behalf of the applicant shall result in disqualification.
- RDT shall not be bound to accept any EOI and reserves the right to shortlist any number of Contractors, construction firms, and engineering agencies it deems suitable.
- RDT may request additional documents/information it may consider necessary to evaluate the organizations.
